

Privacy Policy

This Statement on Confidentiality and Protection of Personal data (hereinafter referred to as the Regulations) is an annex to the User agreement between individuals (Users and Experts) who register on the Site, and the Association "Language Hearts."

All terms used in the Regulations are used in the meanings established User Agreement, including annex to her.

The provision applies to all information that The Association may receive from Users and Experts upon their use of any of the services, programs and products Website (hereinafter referred to as Services, Website Services). Using site services means the unconditional consent of the User / Expert with Regulations.

In case of disagreement with the Regulations, the User / Expert must refrain from using the Site.

1. Personal data of Users and Experts

1.1. In accordance with the legislation of Ukraine, under personal data should be understood as information or a set of information about an individual who is identified or can be specifically identified. Within the framework of these Regulations, under "user's personal data" should be understood as follows:

1.1.1. Personal data that the User / Expert provides information about himself during Registration or in the process use of services. Mandatory for the provision of services the data is marked in a special way. Other information provided by the User/Expert at his/her discretion and provision is not required for Registration or use of services.

1.1.2. Data that is automatically transmitted during the process use using the user installed on the device software, including IP address, information from cookie, information about the user's browser (or another program with through which the Services are accessed), access time, page request address.

1.1.3. Other User information, collection and/or provision

which is defined in the documents regulating the activities individual services of the Site.

1.2. This Statement applies only to the services of the Site.

The Association does not control and is not responsible for the content other sites on the Internet to which the User / Expert may follow links available on the Site, including content.

1.3. As a general rule, an entrepreneur does not check the authenticity personal data provided by Users/Experts.

The Entrepreneur assumes the good faith of the Users / experts and assumes that they provide reliable and sufficient personal information on the issues proposed upon Registration and keep this information up to date condition.

2. Processing of personal data

2.1. The site collects and stores only those personal data that necessary to provide services and provide services (perform agreements and contracts with the User / Expert).

2.2. The Site may use personal information of the user for the following purposes:

2.2.1. Identification of the party within the framework of the Charter and Regulations

Associations;

2.2.2. Providing personalized services;

2.2.3. Communication with the User/Expert, including referral messages (including commercial ones), requests and information, relating to the use of the Services, the provision of services, as well as processing data, requests and applications;

2.2.4. Improving the quality of service, ease of use, development of new services;

2.2.5. Targeting advertising materials;

2.2.6. Conducting statistical and other studies based on anonymized data.

3. Consent of the subject of personal data. Processing conditions personal data and their transfer to third parties

3.1. The site stores personal information of Users in accordance with modern technical standards and requirements.

3.2. Processing of personal data is carried out under the condition provision by the User / Expert of unambiguous consent to processing of such data.

3.3. Consent of the User / Expert to the processing of personal

data is provided during Registration by checking on granting permission to process personal data, in for the purposes of processing set forth in the Regulations.

3.4. The technical means of the Site do not create the possibility of processing personal data until such a mark is placed.

3.5. On personal data of Users and Experts the legal regime of information with limited access to confidential information, except in cases voluntary distribution by the User / Expert of such information for general access to an unlimited number of persons.

3.6. The site has the right to transfer personal information user to third parties in the following cases:

3.6.1. The User / Expert has agreed to carry out such actions;

3.6.2. Such transfer is necessary within the framework of the use of a certain Service or for the provision of a service;

3.6.3. The transfer is provided for by law;

3.6.4. In connection with the replacement of the Association's party to the obligation to user agreements;

3.6.5. In order to ensure the protection of rights and legal interests of the Association or third parties in cases where the User violates the User Agreement.

3.7. When processing personal data of Users, the Association is guided by the norms of the Law of Ukraine "On the Protection of Personal data".

4. Change of personal information by the User

4.1. The User/Expert can change (update, supplement) the personal data provided to them or part thereof, using the function for editing personal data in sections "My Account" and "My Profile" of the user account / An expert available after logging in to the Site.

5. Other user rights

5.1. The Association guarantees the provision of User rights / Expert provided for by the norms of part two of Article 8 of the Law Ukraine "On the protection of personal data", namely:

5.1.1. Know about the sources of collection, the location of your personal data, purposes of their processing, location or place of residence (stay) of the owner or manager of personal data or give appropriate instructions to obtain this information

- to persons authorized by him, except in cases established by law;
- 5.1.2. Receive information about the conditions for providing access to personal data, including information about third parties to whom his personal data is transmitted;
 - 5.1.3. To access your personal data;
 - 5.1.4. Receive no later than thirty calendar days from the date entry of a request, except in cases provided for by law, the response to that his personal data is processed, and also receive the content of such personal data;
 - 5.1.5. Present a reasoned demand to the owner personal data with an objection to the processing of your personal data;
 - 5.1.6. Submit a reasoned request for change or destruction of your personal data by any owner and the processor of personal data, if this data are processed illegally or are inaccurate;
 - 5.1.7. To protect your personal data from illegal processing and accidental loss, destruction, damage due to intentional concealment, failure to provide or untimely provision, as well as protection from the provision of information, which are unreliable or defamatory to honor, dignity and business reputation of an individual;
 - 5.1.8. File complaints regarding the processing of your personal information data to the Commissioner for Human Rights or to the court;
 - 5.1.9. Apply legal remedies in case of violation legislation on the protection of personal data;
 - 5.1.10. Introduce clauses limiting the right to process your personal data when providing consent;
 - 5.1.11. Withdraw consent to the processing of personal data;
 - 5.1.12. Know the mechanism for automatic processing of personal data data;
 - 5.1.13. To be protected from an automated solution that has for its legal consequences.

6. Measures taken to protect personal data

6.1. The site administration does the necessary and sufficient organizational and technical measures to protect personal data User/Expert from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other unlawful actions of third parties persons

7. Change of Regulations

7.1. The Association has the right to make changes to this Position. The new version of the Regulations comes into force from the moment of its

placement, unless otherwise provided by the new edition of the Regulations.

7.2. To the relationship between the User/Expert and the Association, arising in connection with the use of the Regulations is subject to application of the law of Ukraine.
